#### **Current Situation:**

The last few years have been tough for the NZBEF. The popularity of business excellence frameworks, including Baldrige, appears to be on the decline globally, and many membership organisations are facing declining membership numbers in NZ and elsewhere. In addition, we have been struggling financially since the resignation of our CEO Mike Watson in 2014.

Because of our precarious financial situation, in 2016 the NZBEF Board decided that the best option for NZBEF's survival was to merge with a like-minded organisation, while keeping retaining our NZBEF brand.

Under consideration were membership organisations NZIM and NZOQ – NZIM itself was also struggling and NZOQ, who welcomed the idea, seemed a better fit and so in November 2016 it was decided to join NZOQ.

While the NZOQ Board has been supportive, it soon became apparent that the expected financial support was not as forthcoming as originally anticipated. The NZOQ has also suffered declining membership in recent years, and so the NZBEF was expected to pay its own way.

Since the "merge" with NZOQ, both NZOQ and my company, Complete Learning Solutions, have provided financial support in the form of \$10K loans each to keep the NZBEF afloat. On the positive side, the revenue from this conference will help us to recover financially and better serve our members.

During our transition (2016-2018) the NZBEF Advisory Board, chaired by Brett Marsh (2016-17) and Steven Naude of Massey University (2017-18), provided advice and helped us plan the way forward. In addition to Brett and Steven, we wish to acknowledge the following individuals:

Recently, the new NZBEF Board opted not to finalise the "merge" with NZOQ and has re-instated our incorporated society, the New Zealand National Quality Awards Foundation, trading as the New Zealand Business Excellence Foundation (NZBEF). We also have New Zealand Business Excellence Foundation Limited registered with the NZ Companies Office.
